#### Umalusi approves the release of the 2020 national examinations results

After a long and strenuous academic year, Umalusi, the Quality Council in General and Further Education and Training, has approved the release of the 2020 national examinations results after successfully conducting the quality assurance of the management and administration of exit point examinations in the following qualifications per assessment body:

- Independent Examinations Board (IEB) NSC and GETC: ABET
- South African Comprehensive Assessment Institute (SACAI) NSC
- Benchmark Assessment Agency (BAA) GETC: ABET
- Department of Basic Education (DBE) NSC and SC(a)
- Department of Higher Education and Training (DHET) GETC: ABET; NATED N2-N3 Programmes; NC(V)

In the words of the CEO of Umalusi, Dr Mafu Rakometsi, "the 2020 academic year will go down the annals of our history as probably the most difficult one since the dawn of democracy in South Africa." He said this in light of the ramifications of the COVID-19 pandemic, which had an unprecedented impact on the academic year, as well as the conduct, administration and management of the 2020 national examinations.

Dr Rakometsi further conveyed his condolences, on behalf of Umalusi Council, to "the teachers, learners, principals, and support staff at public schools, independent schools, public TVET colleges, private FET colleges, and ABET centres, as well as officials and staff members at District Offices and Provincial Education Departments who lost their friends, family members, relatives and colleagues due to COVID-19."

Despite the challenges presented by COVID-19, Umalusi's quality assurance process focused on the following aspects of its mandate: the external moderation of question papers for all subjects/learning areas/instructional offerings across all qualifications and assessment bodies, verification of a sample of site-based assessment (SBA) marks, monitoring of the assessment bodies' state of readiness to conduct and manage the 2020 national examinations, monitoring the conduct of examinations, monitoring and verification of marking as well as standardisation of results.

**The class of 2020:** The class of 2020 was the seventh Grade 12 cohort to write final examinations under the Curriculum Assessment Policy Statements (CAPS). Furthermore, due to COVID-19 lockdown regulations, assessment bodies were forced to postpone their mid-year examinations to the November end-of-year examinations. Consequently, this increased the number of learners who wrote national examinations in November 2020. As a result, the class of 2020 became the largest cohort in the recent past to sit for the November national examinations.

**Evidence-based reports:** Umalusi has taken note of the evidence-based reports on interventions and improvement strategies implemented by all assessment bodies including the Department of Basic Education and the positive impact of these on the overall assessment system as well as on teaching and learning.

**Improved quality of question papers:** The quality of question papers is a very important aspect of the integrity and credibility of the examination. It is therefore pleasing to see a marked improvement in the overall quality of question papers that were submitted by some of the assessment bodies as more papers are approved after first or second submission to external moderators.

**Irregularities:** Umalusi is deeply disappointed that the 2020 NSC examinations administered by DBE were marred by the leakage of Mathematics Paper 2 and Physical Sciences Paper 2 question papers. Once again, Umalusi appeals to all stakeholders involved in the examination process to refrain from engaging in such unscrupulous acts of dishonesty. Umalusi takes a dim view of paper leakages as they have the potential to compromise the integrity and credibility of the entire examination. It is also worth noting that there are serious consequences for those who are found guilty of such criminal activities, regardless of whether they are learners or officials.

Regarding the outcome of the investigation into the leakage of Mathematics Paper 2 and Physical Sciences Paper 2 question papers in the 2020 NSC examination, Umalusi has made the following observations: The investigation into the leakage of Mathematics Paper 2 and Physical Sciences Paper 2 is not yet complete and is continuing. That said, according to section 21 of the General and Further Education Quality Assurance Act of 2001, as amended, "**21**. (1) The Council may refuse to issue a certificate if a substantial irregularity has occurred in relation to an external assessment. (2) The Council may cancel a certificate that has been issued to a learner if on investigation the Council found that the learner has not met the requirements for the qualification. (3) The Council may by notice in writing direct a learner whose certificate has been cancelled to return the certificate to the Council within three weeks after such notice."

This means that Umalusi can still nullify the certificates of candidates who are found guilty of leaking the two papers even after receiving their results. About the case presented to the Pretoria High Court in December 2020 regarding the rewrite of examinations, Council has reiterated the statement issued in December last year that even though it was disappointed by the outcome of the case it respects the decision taken by the court. Furthermore, there is no doubt that the use of technology in the spread of leaked papers has added another challenge to the management of irregularities by assessment bodies. Therefore, Umalusi encourages all assessment bodies to strengthen their systems and do everything they can to avert the leakage of examination papers in future.

**Standardisation of results:** To mitigate the sources of variability that impact learner performance from one year to another. (e.g., cognitive demand and difficulty levels of questions, interpretation of questions and marking guidelines, curriculum changes, etc.) standardisation is employed as an important 'quality assurance process used the world over.'

Standardisation aims, in the main, to achieve equivalence of the standard of the examination across years, subjects and assessment bodies and to deliver a relatively constant product to the market: universities, colleges and employers.

We can expect that when standards of examinations are equivalent certain statistical mark distributions should correspond. It is this principle of 'correlation' that forms the basis for comparing distributions with norms/historical averages that are developed over 5 years. This comparison includes qualitative data, medians, means, pass/failure

and distinction rates and pairs analyses, which play a significant role in the absence of historical data.

The adjustments decided by the Assessment Standards Committee (ASC) of Umalusi consistently follow certain guiding principles. The ASC consists of academics with extensive experience and expertise in statistical moderation, assessment, curriculum and education.

However, EXCO is satisfied that there were no systemic irregularities reported which might have compromised the credibility and integrity of the **November 2020 National Senior Certificate (NSC)** examinations administered by the **Independent Examinations Board (IEB)**.

The Executive Committee of Council approves the release of the IEB results of the **November 2020 NSC** examinations based on the following:

The November 2020 NSC examinations were administered in accordance with the examination policies and regulations.

The IEB is required to:

- Block the results of candidates implicated in irregularities pending the outcome of further IEB investigations and Umalusi verification.
- Ensure that Umalusi is informed before new examination centres including examination centres outside the borders of South Africa are established; and

 Address the directives for compliance and improvement highlighted in the Quality Assurance of Assessment report and submit an improvement plan by 26 March 2021.

The Executive Committee of Council commends the IEB for conducting a successful and credible examination despite challenges faced during 2020 including COVID-19.

Having studied all the evidence presented, the Executive Committee of Council (EXCO) noted the isolated irregularities reported during the writing and marking of examinations.

However, EXCO is satisfied that there were no systemic irregularities reported which might have compromised the credibility and integrity of the **November 2020 National Senior Certificate (NSC)** examinations administered by the **South African Comprehensive Assessment Institute (SACAI)**.

The Executive Committee of Council approves the release of the SACAI results of the **November 2020 NSC** examinations based on the following:

The November 2020 NSC examinations were administered in accordance with the examination policies and regulations.

The SACAI is required to:

- Ensure compliance with the conditions for its provisional accreditation as an Assessment Body including not assisting unaccredited examination centres to bypass the registration and accreditation requirements; and
- Address the directives for compliance and improvement highlighted in the Quality Assurance of Assessment report and submit an improvement plan by 26 March 2021.

The Executive Committee of Council commends the SACAI for conducting a successful examination despite challenges presented by COVID-19.

#### **DEPARTMENT OF BASIC EDUCATION (DBE): NSC**

Having studied all the evidence presented, the Executive Committee (EXCO) of Umalusi Council noted the isolated irregularities reported during the writing and marking of examinations as well as the group copying cases reported in 4 provinces involving 893 candidates.

In addition, Umalusi has noted with concern the serious irregularities regarding the leakage of Mathematics Paper 2 and Physical Sciences Paper 2 question papers.

However, EXCO is satisfied that there were no systemic irregularities reported, which might have compromised the overall credibility and integrity of the **November 2020 National Senior Certificate (NSC)** examinations administered by the **Department of Basic Education (DBE)**.

The Executive Committee of Council approves the release of the DBE results of the **November 2020 NSC** examinations based on available evidence that the examinations were administered in accordance with the examination policies and regulations.

In respect of the generally identified irregularities, the DBE is required to:

- block the results of candidates implicated in irregularities including the candidates involved in group copying pending the outcome of further DBE investigations and Umalusi verification; and
- tighten the security at all levels to ensure that there are no leakages of question papers.

In light of the unprecedented circumstances regarding the leakages of Mathematics Paper 2 and Physical Sciences Paper 2 question papers, EXCO resolved as follows:

• Where there has been unauthorized access to question papers and where there is evidence beyond being a passive recipient of the papers, the results of the implicated candidates should be blocked pending further investigation. • In all other cases, the results should be released.

The DBE is required to address the directives for compliance and improvement highlighted in the Quality Assurance of Assessment report and submit an improvement plan by

26 March 2021.

The Executive Committee of Council commends the DBE for conducting a successful and credible examination despite challenges presented by COVID-19 and the leakage of question papers through social media.

In light of the unprecedented circumstances pertaining to the leakages of the Mathematics Paper 2 and Physical Sciences Paper 2 question papers, EXCO resolved as follows:

- Where there has been unauthorised access to question papers and where there is evidence beyond being a passive recipient of the papers, the results of the implicated candidates should be blocked pending further investigation
- In all other cases, the results should be released.

The DBE is required to address the directives for compliance and improvement highlighted in the Quality Assurance of Assessment report and submit an improvement plan by 26 March 2021.

The Executive Committee of Council commends the DBE for conducting a successful and credible examination despite challenges faced during 2020 including COVID-19.
